





We have an awesome responsibility of being there for other people in their most vulnerable moments, and we do not take that lightly. We are proud, strong, resilient, humble, empathetic, courageous advocates who do not give up in the face of injustice. I continue to fulfill my purpose by being of service to others and contribute to the field by promoting the use of strength-based language. There is so much to be proud of as a member of the Saving Innocence team.

Diana Redeemer, MA (Resource Family **Administrator)** — Saving Innocence means everything to me. Working for an organization that is dedicated to and passionate about helping kids is so fulfilling and exciting. Saving Innocence has shown me an enormous network of people who care about children and are committed to a larger purpose of ending child sex trafficking. The desire to help others shines from our SI team and allows us to connect with our clients in an unimaginable way. We are making a positive impact that will last a lifetime.

Katelyn Gray (Lead Crisis Case Manager/ Advocate) — For me, Saving Innocence represents a community of fiercely kind people who stand by each other. To work at Saving Innocence means treating our clients in the same way that we treat each other: with unconditional love and grace upon grace. Through the unending support of the team, I have been able to support a child through a very difficult season, wherein she experienced great loss and joy in addition to her trauma. She asked me to be with her through the delivery of her child (which, due to COVID-19 and other complications, meant staying four days and three nights at the hospital with her). This gave me a front-row seat to the unconditional love she has given her child, since she had someone standing by her. I am beyond proud of her ability to still love despite her extreme difficulties.

Leah Albright-Byrd (Board Member) — A mentor of mine taught me that you have to focus on "changing an atmosphere before you can change a culture." I serve with Saving Innocence because it is a thermostat instead of a thermometer; it is helping to change culture in Los Angeles and our nation in ways that are desperately needed. As a person who has lived through human trafficking, I have longed to support a group of mission-minded people who are serving, empowering, and advocating on behalf of this vulnerable population.
